# Purpose of role

The Lecturer in Fashion Imaging and Digital Illustration is responsible for teaching, curriculum development, and on-going scholarship on the BA (Hons) Fashion Imaging and Illustration course. This course is part of the Fashion Media programme in the School of Media and Communication at London College of Fashion. The post-holder will work collaboratively within a course team, deploying specialist expertise to develop pedagogy and the curriculum in innovative and critical directions.

The post-holder will be expected to undertake:

- Responsibility for a year group of undergraduate students' pastoral support, progress and attendance, maintaining records and liaising with colleagues as appropriate
- Pedagogic and curriculum development that stimulate thought and practice that challenge the canon of Fashion Imaging and Illustration with the aim of promoting diversity and inclusivity
- Expand the capacity of the course design to meet the need for students to include contemporary digital imaging skills involving 2D or 3D imaging and moving image within their practice.

This responsibility is of immediate strategic importance and may develop or change in the light of new priorities.

The post-holder is expected to uphold and implement the policies and procedures of University of the Arts London and the College.
