<p><b>Purpose of role</b></p> <p>The Lecturer in Fashion and Sustainability is responsible for teaching, curriculum development, and on-going scholarship across the School of Design and Technology. The post-holder will work collaboratively within a course team, deploying specialist expertise to develop pedagogy and the curriculum in innovative and critical directions.</p> <p>The post-holder will be expected to undertake:</p> <ul style="list-style-type: none"> <li>• Responsibility undergraduate students' academic support, progress and attendance, maintaining records and liaising with colleagues as appropriate</li> <li>• Pedagogic and curriculum development that stimulate thought and practice that challenge the canon of fashion and sustainability with the aim of promoting diversity and inclusivity</li> <li>• Expand the capacity of the course design to meet the need to deliver sustainability subjects to undergraduate and postgraduate students.</li> </ul> <p>This responsibility is of immediate strategic importance and may develop or change in the light of new priorities.</p> <p>The post-holder is expected to uphold and implement the policies and procedures of University of the Arts London and the College.</p>	
<p><b>Duties and responsibilities</b></p> <p><i>Teaching:</i></p> <ul style="list-style-type: none"> <li>• To undertake teaching as appropriate to your areas of expertise and the subject areas of the Course, Programme or College.</li> <li>• To stay abreast of research and other developments in fashion and sustainability education and to ensure that these developments are reflected in the curriculum in consultation with colleagues and within the structures and mechanisms established by the University and the College.</li> <li>• To extend the level of subject expertise and critical understanding on the Course so as to keep the curriculum at the forefront of critical professional practice and relevant to a diverse and international range of students.</li> <li>• To conduct assessment, formative and summative, which is rigorous, fair and clear and complies with the policies established by the University and the College.</li> <li>• To provide both academic and pastoral support to students, monitoring progress and attendance, and maintaining appropriate records.</li> </ul> <p><i>Professional</i></p> <ul style="list-style-type: none"> <li>• To initiate or engage in pedagogic inquiry and teaching development as required with the specific focus of improving student engagement, experience and progression.</li> <li>• To participate in the engagement of students in feedback processes, and in consultation with the course team and course leader, respond to the issues raised through this engagement.</li> <li>• In consultation with the Course Leader, to liaise with other staff to enhance and extend the educational and creative links between the Course and other courses across the Programme, College and University.</li> <li>• To undertake scholarly activity (including research, knowledge exchange or teaching)</li> </ul>

- To contribute to the devising and delivery of activities (including income generation) which will benefit students' educational experience and graduate outcomes.
