<p>Purpose of role</p> <p>The Lecturer in Fashion Management: Consumer Behaviour is responsible for teaching, curriculum development, and on-going scholarship on MSc (Integrated) Strategic Fashion Management. This course is part of the Leadership and Management Programme in the Fashion Business School at London College of Fashion. The post-holder will work collaboratively within a course team, deploying specialist expertise to develop pedagogy and the curriculum in innovative and critical directions.</p> <p>The post-holder will be expected to undertake</p> <ul style="list-style-type: none"> responsibility for a year group of undergraduate students' pastoral support, progress and attendance, maintaining records and liaising with colleagues as appropriate and pedagogic and curriculum development that stimulates thought and practice in the application of consumer behaviour in fashion. <p>This responsibility is of immediate strategic importance and may develop or change in the light of new priorities.</p> <p>The post-holder is expected to uphold and implement the policies and procedures of University of the Arts London and the College.</p>	
<p>Duties and responsibilities</p> <p><i>Teaching:</i></p> <ul style="list-style-type: none"> To undertake teaching as appropriate to your areas of expertise and the subject areas of the Course, Programme or College. To stay abreast of research and other developments in e-commerce education and to ensure that these developments are reflected in the curriculum in consultation with colleagues and within the structures and mechanisms established by the University and the College. To extend the level of subject expertise and critical understanding on the Course so as to keep the curriculum at the forefront of professional practice. To conduct assessment, formative and summative, which is rigorous, fair and clear and complies with the policies established by the University and the College. To provide both academic and pastoral support to students, monitoring progress and attendance, and maintaining appropriate records. <p><i>Professional</i></p> <ul style="list-style-type: none"> To initiate or engage in pedagogic inquiry and teaching development as required with the specific focus of improving student engagement, experience and progression. To participate in the engagement of students in feedback processes, and in consultation with the course team and course leader, respond to the issues raised through this engagement. In consultation with the Course Leader, to liaise with other staff to enhance and extend the educational and creative links between the Course and other courses across the Programme, College and University. To undertake scholarly activity (including research, knowledge exchange or teaching) relevant to the application of consumer behaviour in fashion.
