<p>Purpose of role</p> <p>The Lecturer in Communication and Digital Innovation is responsible for teaching, curriculum development, and on-going scholarship on the Creative Direction for Fashion course. This course is part of the Fashion Communication Programme, within the School of Media and Communication, at London College of Fashion. The post-holder will work collaboratively within a course team, deploying specialist expertise to develop pedagogy and the curriculum in innovative and critical directions.</p> <p>The post-holder will be expected to undertake:</p> <ul style="list-style-type: none"> • Expand the capacity of the course design and teaching to meet the future needs of technology and communication in fashion. Interest and expertise in emerging technologies and innovations, interactive media, interface and UX/UI design. • Supporting year tutors with the pastoral support, progress and attendance, maintaining records and liaising with colleagues • Responsibility for part of a year group of undergraduate students' pastoral support, progress and attendance • Pedagogic and curriculum development that stimulate thought and practice that challenge the subject area with the aim of promoting diversity and inclusivity <p>This responsibility is of immediate strategic importance and may develop or change in the light of new priorities.</p> <p>The post-holder is expected to uphold and implement the policies and procedures of University of the Arts London and the College.</p>

- To participate in the engagement of students in feedback processes, and in consultation with the course team and course leader, respond to the issues raised through this engagement.
- In consultation with the Course Leader, to liaise with other staff to enhance and extend the educational and creative links between the Course and other courses across the Programme, College and University.
- To undertake scholarly activity (including research, knowledge exchange or teaching) relevant to the subject area.
- To contribute to the devising and delivery of activities (including income generation) which will benefit students' educational experience and graduate outcomes.
