Purpose of role

The Lecturer in Hair and Make-up for Fashion is to undertake teaching, curriculum development, and on-going scholarship on this Fashion Media course. This role requires a candidate that is knowledgeable regarding the contemporary fashion and beauty landscape, and has the relevant academic and professional profile to be able to contribute to pedagogy and the curriculum in innovative and critical directions, including contextualising and theorising beauty and supporting its important position within the Fashion Media Industry.

Purpose of role

The post-holder will be expected to undertake –

- Delivery of presentations, seminars and activities that share content linked to Hair and Make-up for fashion that is relevant to Fashion Media unit briefs.
- Developing and presenting key academic material and information required for professional practice, providing information that shares expertise in the field of beauty and representation within fashion media.
- To support and extend the School's existing links with those in professional practice and related industries as appropriate to the development, maintenance and delivery of teaching programmes.
- To maintain a professional level of subject expertise by being aware of relevant industrial and technological developments in the field.
- To support the process of reviewing Fashion Hair and Make-up units and contributing to the identification and validation of new units.
- Responsibility for a year group of undergraduate students' pastoral support, progress and attendance, maintaining records and liaising with colleagues as appropriate
- Pedagogic and curriculum development that stimulate thought and practice that challenge the canon of beauty for fashion media with the aim of promoting diversity and inclusivity.
- The post-holder is expected to uphold and implement the policies and procedures of University of the Arts London and the College.

Duties and Responsibilities

Teaching

- To undertake teaching as appropriate to your areas of expertise and the subject areas of the Course, Programme or College.
- To stay abreast of research and other developments in hair and make-up for fashion and to ensure that these developments are reflected in the curriculum in consultation with colleagues and within the structures and mechanisms established by the University and the College.

- To extend the level of subject expertise and critical understanding on the Course to keep the curriculum at the forefront of critical creative, and professional practice and relevant to a diverse and international range of students.
- To conduct assessment, formative and summative, which is rigorous, fair, and clear and complies with the policies established by the University and the College.
- To provide both academic and pastoral support to students, monitoring progress and attendance, and maintaining appropriate records.

Professional

- To initiate or engage in pedagogic inquiry and teaching development as required with the specific focus of improving student engagement, experience, and progression.
- To participate in the engagement of students in feedback processes, and in consultation with the course team and course leader, respond to the issues raised through this engagement.
- In consultation with the Course Leader, to liaise with other staff to enhance and extend the educational and creative links between the Course and other courses across the Programme, College, and University.
- To undertake scholarly activity (including research, knowledge exchange or teaching) relevant to the subject of Hair and Make-up for Fashion.
- To contribute to the devising and delivery of activities (including income generation) which will benefit students' educational experience and graduate outcomes.
- Familiar with debates and research relating to decolonising the curriculum and awarding gaps within the HE Sector (Academic).

Quality, Management and Enhancement

- To contribute to strategic planning in relation to the course/programme in areas such as student recruitment, the deployment of resources, research and knowledge exchange.

- To contribute to the monitoring of the quality of teaching and learning through continuous course monitoring and to contribute to quality, management and enhancement activities across the School, College and University.
- To be a member of the Course Committee of the Course and of such other committees, including other course committees and examination boards, as the Dean of School or Head of College require.

General

- To perform such duties consistent with your role as may from time to time be assigned to you anywhere within the University.
- To undertake health and safety duties and responsibilities appropriate to the role.

- To personally contribute towards reducing the university's impact on the environment and support actions associated with the UAL Sustainability Manifesto (2016 – 2022).


