## Purpose of role

The Lecturer in Design Management will be responsible for teaching, curriculum development, and on-going scholarship on the BA Design Management course. This course is part of the Branding & Design Innovation programme within the Design School at London College of Communication. The post-holder will work collaboratively within a course team, deploying specialist expertise to develop pedagogy and the curriculum in innovative and critical directions.

The post-holder will be expected to undertake:

- Developing with colleagues across the course the distinctive approach to delivery of design management unit content at undergraduate level.

- Pedagogic and curriculum development that stimulates thought and practice that challenge
  the canon of branding and identity, promoting diverse voices and questioning normative
  systems such as race, privilege etc.
