# Purpose of role:

The Senior Lecturer in Lecturer in Fashion Business Research Methods is responsible for teaching, course development, and on-going scholarship on the MA Strategic Fashion Marketing, MA Global Fashion Retail and MA Fashion Design Management courses. These courses are part of the Fashion Business School at the London College of Fashion. The post-holder will work collaboratively within a course teams, deploying specialist expertise to develop pedagogy and the curriculum in innovative and critical directions.

The post-holder will be expected to undertake:

- Responsibility for a year group of undergraduate students' pastoral support, progress and attendance, maintaining records and liaising with colleagues as appropriate
- Pedagogic and curriculum development that stimulate thought and practice that challenge the canon of research design and methods with the aim of promoting diversity and inclusivity
- To champion appropriate research design and methods across MA Strategic Fashion Marketing, MA Global Fashion Retail and MA Fashion Design Management to ensure consistent high quality research outputs from students across the courses.
- To work in collaboration with relevant staff to design and deliver teaching of specialist research methodologies and provide individual support for members of staff/staff teams as required.
- Expand the capacity of the course design to meet the need to lead and support research orientated units for the PG courses, including teaching and learning responsibilities, project development with students, assessment, and associated administrative duties.

This responsibility is of immediate strategic importance and may develop or change in the light of new priorities.

The post-holder is expected to uphold and implement the policies and procedures of University of the Arts London and the College.

Teaching:

- To undertake teaching as appropriate to your areas of expertise and the subject areas of the Course, Programme or College.

- In consultation with the Course Leader, to liaise with other staff to enhance and extend the educational and creative links between the Course and other courses across the Programme, College and University.
- To undertake scholarly activity (including research, knowledge exchange or teaching) relevant to the research methods subject.
- To contribute to the devising and delivery of activities (including income generation) which will benefit students' educational experience and graduate outcomes.

- To contribute to strategic planning in relation to the course/programme in areas such as student recruitment, the deployment of resources, research and knowledge exchange
- To lead curriculum design developments in the context of revalidation, in consultation with the course leaders, in order to further strategic objectives at course and college level
