<p>Purpose of role</p> <p>The Lecturer in Strategic Design and Innovation is responsible for teaching, curriculum development, and on-going scholarship on the Critical Practice in Fashion Media course. This course is part of the Fashion Communication Programme, within the School of Media and Communication, at London College of Fashion. The post-holder will work collaboratively within a course team, deploying specialist expertise to develop pedagogy and the curriculum in innovative and critical directions.</p> <p>The post-holder will be expected to undertake:</p> <ul style="list-style-type: none"> • Expand the capacity of the course design and teaching to meet the future needs of strategy, innovation and critical practice in fashion media and communication. Interest and expertise in strategic foresight, design research and emerging technologies and innovations within the field of media and communication. • Shared responsibility for a year group of undergraduate students' pastoral support, progress and attendance, maintaining records and liaising with colleagues as appropriate • Pedagogic and curriculum development that stimulates thought and critical practice that challenges and expands fashion media and communication with the aim of promoting diversity and inclusivity <p>This responsibility is of immediate strategic importance and may develop or change in the light of new priorities.</p> <p>The post-holder is expected to uphold and implement the policies and procedures of University of the Arts London and the College.</p>

- To contribute to the devising and delivery of activities (including income generation) which will benefit students' educational experience and graduate outcomes.
