<p>Purpose of role</p> <p>Lecturer in Fashion Jewellery, 3D Development and Realisation is responsible for teaching, curriculum development, and on-going scholarship in the field of Fashion Jewellery. The post-holder will work collaboratively within a course team, deploying specialist expertise to develop pedagogy and the curriculum in innovative way.</p> <p>The post holder will be an experienced jewellery designer who has professional experience in the fashion industry. The role requires the delivery of lectures/seminars and practical demonstrations underpinned by the interrelationship between design, 3D development and realisation in relation to fashion jewellery concept development, encompassing traditional craft and CAD.</p> <p>The post-holder will be expected to undertake:</p> <ul style="list-style-type: none"> • Responsibility for a year group of undergraduate students' pastoral support, progress and attendance, maintaining records and liaising with colleagues as appropriate. • Pedagogic and curriculum development that stimulate thought and practice that challenge the canon of Fashion Jewellery with the aim of promoting diversity and inclusivity • Expand the capacity of the design and construction ethos of the course to meet the need of future challenges in Fashion Jewellery and develop the subject within a wider fashion context. <p>This responsibility is of immediate strategic importance and may develop or change in the light of new priorities.</p> <p>The post-holder is expected to uphold and implement the policies and procedures of University of the Arts London and the College.</p>

- To participate in the engagement of students in feedback processes, and in consultation with the course team and course leader, respond to the issues raised through this engagement.
- In consultation with the Course Leader, to liaise with other staff to enhance and extend the educational and creative links between the Course and other courses across the Programme, College and University.
- To undertake scholarly activity (including research, knowledge exchange or teaching) relevant to the subject of Fashion Jewellery Design.
- To contribute to the devising and delivery of activities (including income generation) which will benefit students' educational experience and graduate outcomes.
