<p>Purpose of the role</p> <p>The Course Leader in User Experience Design will be responsible for leading and managing the BA in terms of curriculum development, teaching & learning and on-going research and scholarship in experience design. This course is part of the Interaction Design & Visual Communication programme within the Design School at London College of Communication. The post-holder will work collaboratively within the programme and lead the course team, deploying specialist expertise to develop inclusive pedagogy and the curriculum in critical and inventive directions.</p> <p>To be responsible to the Programme Director for -</p> <ul style="list-style-type: none"> • The academic leadership and management of the Course, including the maintenance and enhancement of standards and responsibility for the design, development and delivery of the curriculum. • The day to day management of the Course including all areas of learning, teaching and assessment of students as well as resources allocated. • Observing and implementing the policies and procedures of the University and the College. • Developing the curriculum that encourages students to develop as creative, confident and critical practitioners and situates the discipline within relevant debates

Duties and Responsibilities

Academic

Analyse data on student progression and achievement with a view to identifying issues and trends and formulating appropriate action in response.

Contribute to the work of the academic committees of the University and, where appropriate, act as Chair.

Curriculum Design, Content and Organisation

Ensure that the curriculum is relevant, current and consistent with the mission of the Programme and the vision for the course.

Ensure that the delivery of the curriculum is organised and resourced appropriately to the academic award, and to the learning styles and developmental stages of the students

Learning Teaching and Assessment

Ensure that the learning (teaching and assessment) methods employed on the Course are appropriate to the academic award, resources allocated and the demands of the subject and the learning styles and developmental stages of the students.

Plan and manage the assessment process for the Course, to comply with University policy and appropriate academic standards to ensure students are given constructive and timely feedback that helps them improve.

Contribute to University committees, such as Assessment Panels, Boards of Examiners and their sub-boards, as appropriate.

Undertake such teaching duties as are appropriate to the requirements of the course and consistent with your areas of expertise.

Student Support and Guidance
