- Contributing to pedagogic and curriculum development that stimulate thought and practice that challenge Acting practices with the aim of promoting diversity and inclusivity
- Contributing to the creation of a lively, engaging and progressive pedagogical practice and environment in Acting and Performance
- Contributing to all areas of training, teaching, learning and assessment of students
- Sharing responsibility for a year group of undergraduate students' pastoral support, progress and attendance, keeping records and liaising with colleagues as appropriate
- Contributing to the Research, Professional practice, and/or Knowledge Exchange environment of the School of Performance, including leading collaborative research and/or knowledge exchange activities and producing outcomes of a demonstrably high quality

Teaching

- To provide both academic and pastoral support to students, monitoring progress and attendance, and maintaining appropriate records.

- In consultation with the Course Leader, to liaise with other staff to enhance and extend the educational and creative links between the Course and other courses across the Programme, College and University.
