**Purpose of the role:**

To be responsible to the Programme Director for:

- The academic leadership and management of the Course, including the maintenance and enhancement of standards and responsibility for the design, development and delivery of the curriculum.
- The day-to-day management of the course including all areas of learning, teaching and assessment of students as well as resources allocated.
- Observing and implementing the policies and procedures of the University and the College.
- Actively practicing at the forefront of emergent digital and social channels, immersive technologies, techniques and platforms of graphic and media design practice.
- Leading and managing strategic change which delivers continuous improvement with a focus on meeting course KPIs including retention, achievement, and improving the student experience.
- Through research, knowledge exchange and practice leading on the continuous development of a distinctive approach to the practice of Graphic and Media Design and actively contribute towards building an evolving and interdisciplinary community of practice in this area able to work across other fields and industries.
- Develop and strengthen the international profile of BAGMD, the School and LCC through an active alumni and industry and/or practice network.
