<p>Purpose of role</p> <p>The Lecturer in Fashion Accessories, Product Design and Innovation is responsible for teaching, curriculum development, and on-going scholarship on BA (Hons) Cordwainers Fashion Bags and Accessories: Product Innovation and Development. This course is part of the School of Design and Technology at London College of Fashion. The post-holder will work collaboratively within a course team, deploying specialist expertise to develop pedagogy and the curriculum in innovative and critical directions.</p> <p>The post-holder will be expected to undertake:</p> <ul style="list-style-type: none"> • Responsibility for a year group of undergraduate students' pastoral support, progress and attendance, maintaining records and liaising with colleagues as appropriate • Pedagogic and curriculum development that stimulate thought and practice that challenge the canon of fashion accessories, 3D development and realisation with the aim of promoting diversity and inclusivity • Undertake teaching, assessment, unit management and curriculum development <p>This responsibility is of immediate strategic importance and may develop or change in the light of new priorities.</p> <p>The post-holder is expected to uphold and implement the policies and procedures of University of the Arts London and the College.</p>
