#### Purpose of role:

The Senior Lecturer in Hair, Make-Up and Prosthetics for Performance is responsible for teaching, course development, and on-going scholarship on the BA (Honours) Hair, Make-Up and Prosthetics for Performance. This course is part of the Performance Programme at London College of Fashion. The post-holder will work collaboratively within a course team, deploying specialist expertise to develop pedagogy and the curriculum in innovative and critical directions.

The post-holder will be expected to undertake:

- Responsibility for a year group of undergraduate students' pastoral support, progress and attendance, maintaining records and liaising with colleagues as appropriate
- Pedagogic and curriculum development that stimulate thought and practice that challenge the canon of [subject] with the aim of promoting diversity and inclusivity
- Contribute to the digital uplift of the Performance Programme and the ongoing development of the Performance Programme offer
- Course Leader and course management support

This responsibility is of immediate strategic importance and may develop or change in the light of new priorities.

The post-holder is expected to uphold and implement the policies and procedures of University of the Arts London and the College.

## Duties and responsibilities:

Teaching:

  Programme, College and University.
- To undertake scholarly activity (including research, knowledge exchange or teaching) relevant to the subject
- To contribute to the devising and delivery of activities (including income generation) which will benefit students' educational experience and graduate outcomes.

- To lead curriculum design developments in the context of revalidation, in consultation with the course leader, in order to further strategic objectives at course and college level

- To be a member of the Course Committee of the Course and of such other committees, including other course committees and examination boards, as the Dean of School or Head of College require.
