<p><b>Duties and Responsibilities</b> In consultation with academic, administrative, managerial and technical colleagues (as appropriate) to:</p> <p><b>Academic</b> Contribute to the academic mission of the Leadership &amp; Management Programme and its implementation as an active participant within the University and College committee structures, ensuring clarity of identity, currency of subject agendas, relevance of learning methods and the fulfilment of appropriate standards at each level of study.</p> <p>Provide the vision for the BSc (Hons) Fashion Management course, set the agenda for its development and maintaining and enhancing quality.</p> <p><b>Quality Management and Enhancement</b> Undertake the effective monitoring of the BSc (Hons) Fashion Management course and lead enhancement activities.</p> <p>Contribute to, and where appropriate lead on the process of course development, minor modifications, major changes, validation, revalidation and review by the University, external agencies and professional bodies in liaison with relevant Deans/Associate Deans.</p> <p>Analyse data on student progression and achievement with a view to identifying issues and trends and formulating appropriate action in response.</p> <p>Contribute to the work of the academic committees of the University and, where appropriate, act as Chair.</p> <p><b>Curriculum Design, Content and Organisation</b> Ensure that the curriculum is relevant, current and consistent with the mission of the Programme and the vision for the course.</p>	

Ensure that the delivery of the curriculum is organised and resourced appropriately to the academic award, and to the learning styles and developmental stages of the students

#### *Learning Teaching and Assessment*

Ensure that the learning (teaching and assessment) methods employed on the BSc (Hons) Fashion Management course are appropriate to the academic award, resources allocated and the demands of the subject and the learning styles and developmental stages of the students.

Plan and manage the assessment process for the BSc (Hons) Fashion Management course, to comply with University policy and appropriate academic standards to ensure students are given constructive and timely feedback that helps them improve.

Contribute to University committees, such as Assessment Panels, Boards of Examiners and their sub-boards, as appropriate.

Undertake such teaching duties as are appropriate to the requirements of the course and consistent with your areas of expertise.
